ReFLEX CES's IP cores/tools are subject to US export controls, whether or not they are exported directly from the US or delivered from an international location to our customers. US export controls also govern re-exports of ReFLEX CES's IP cores/tools as they are US-origin products. ReFLEX CES's standard IP cores/tools are not governed by International Traffic in Arms Regulations (ITAR), or the United States Munitions List (USML), which are administered by the Department of State.

The applicable export controls promulgated by the US Department of Commerce, Bureau of Industry and Security (BIS) are established based on the export classification of the particular IP core/tool. The export Control Classification Number (ECCN) of ReFLEX CES's IP cores/tools is determined using the Commodity Classification List. The "exporter-of-record" or re-exporter (for shipments from non-US locations) is responsible for determining the ECCN; this responsibility may not be shifted to other parties. Regardless of the ECCN, US export controls prohibit the export or re-export to specified end users (e.g., the Denied Parties Listing) and end for end uses (e.g., for use in missile technology, etc.). Note also that certain countries maintain import controls with which the export and/or importer are required to comply.

Please note that once an IP core is incorporated into a logic design and/or programmed into an Intel PLD/FPGA device, the logic design and/or programmed device must be classified based on the functionality of the specific program and/or device into which the program has been implemented.

We have provided above the current ECCN number and other information for certain IP cores/tools. In addition, regardless of ECCN classifications, US export control laws have certain general prohibitions upon the exports/re-exports to certain countries, end uses and end users.
